Deans need to communicate more with chairs when dealing with dropping and adding courses Students who register late tend to be unsuccessful People who worked the week before who were not on contract were paid to do so Chairs were paid according the others were paid for advising As we decrease sections there will be fewer adjuncts Are we doing advising on this campus effectively We could have a much better advising system
