 - -Withdrawal date moved to May 1
 - -Some colleges are not going to academically dismiss students need to speak to FA
 - -With re-admission, its somewhat scattered. Recommendations have been made by a committee.
 - Will make a difference with re-admits
 - -Academic Affairs and Student Affairs working with students who have disappeared.

Retention and Coaching teams are reaching out. Laptops are available (100 currently).

- -What some of the students are noticing about some of the courses courses are inconsistent.
- -Summer classes are now online. Training will be available for Bb shells. Shells were given to everyone so if people do not have Bb training please do so.
- -Have a Plan B for Fall JUST IN CASE being online.
- -Placement hard to do remotely. Examity is having some issues.

a) Academic Grievance

- i. Grievance brought to Dr. Haynes' desk March 17, 2020
- ii. Ad hoc committee formed request for approval sent to body via e-mail
 - 1. No objections ad hoc committee is reviewing appeal

Dani Berchtold is taking the lead on this committee.

- b) Middle States A. Haggerty
 - -Process is continuing. Drafts should be completed by the end of this month.
- c) Stephanie Conference call with Chancellor
 - -There are funds 14k needed for SUNY students. 10k have been distributed.
 - -Budgets we lost the funding floor.
 - -\$850 million dollars lost $-\frac{1}{2}$ is medical. FEMA may offset some of this.
 - -Community Colleges are set to lose \$7 million.
 - -Chancellor has a work group for budgeting
 - -SUNY is on a hiring freeze. Will this lead to imbalance with adjuncts?
 - -Travel is frozen.
 - -Work groups for faculty learning distance learning.
 - -Fall strategies online, blended not able to be determined yet.
 - -Communities rallying around their students some colleges had road blocks into the school.
 - -EOP will going fully online. For the summer academy too.
 - -Pathways turn denial letters into referral letters
 - -P/F was discussed. The Chancellors expects State Ops to accept GEN ED classes as P/F
 - -Assessment Efforts should continue.

IX. New Business

- a) Credit Hour Policy M. Guzzi and K. Weber
 - -Marty met with Penny and Broome does not have such policy. Scheduling instructions are more comprehensive. He audited some courses. 1 credit = 50 minutes and 2 hours outside of classes for a 15-week course. This needs to be approved by the Board of Trustees
- b) Budget Update M. Sullivan (See handout attached)
 - -There was a 4-page handout, relative to the current budget (same as last months).
 - -Some main drivers:
 - -Revenue Projected enrollment decline of 6%. Now we are at a 9%.
 - Payroll \$800 thousand negative variance.
 - -How to offset row 10 and 11. FF. No travel. Contracts. Departments can send requests.

Some funds have been transferred back in to accounts. Capital Repairs was reduced.

- -Number 1 objective is to identify is to balance the budget each year. We've done it the last 3 years.
- -COVID 19 has yet to play out. Right now, summer is down 30%. Summer is only about 4% of our total enrollment.
- -College has incurred additional costs for online learning.
- -Since closing down the campus for COVID we may be saving HLP.
- -We have a reasonable shot at balancing the budget. Spend less.
- -Page 3 FTE and student enrollment / graduation rates are underlying factors beyond COVID
- 19. View the 5-year trend. Actuals FTE's are declining. HS grads are declining 5-7%.
- -Down state is the main force for the dorms (330 students).
- -There is a challenge for next year (pre-COVID 19).
- -Hard Freeze for filling positions. \$3.2-million-dollar deficit. Trying to avoid layoffs.
- -Fees might be increased for students
- -Carla Concerned that the college's number one priority should balance the budget, when should it not be our students shouldn't we offer the classes they need? With increased sections

- it was to accommodate student needs. Dr. Drumm's email about a grant - \$4.5 million.

Cutting sections is the worst thing we can do. If we support retention – those non-instructional people help us support our students. I've been here since 1986 – she has seen this happen over and over. We say we want to retain – but we don't actually do it.

Joe- With layoffs- as a FA rep. – the Paradox with Dr. Battisti. Mr. Sullivan – its donated.

M. Sullivan – the finance dept. # 1 priority is to balance the budget. COVID-19 is a perfect example to set aside funds. Any operation should have 3 months cash on hand.

The next 5 years are going to be tough on the budget.

Gina- Can we extend time? Stephanie motioned, Kerry seconds. Motion to extend 15 minutes. 2 minutes for M. Sullivan. 13 minutes for P/F motion.

- c) Faculty/Staff Your Voice Matters postponed to April 9 via Zoom
- d) Pass/Fail option during COVID-19 Discussion
 - -Andrea one of the attachments Google Docs of compiled comments from constituents.
 - -Joe Spence was invited to talk about transfers.
 - -Recommendation to Dr. Haynes about P/F.
 - -Equity is a focus.
 - -Stephanie sister colleges are exploring this. Seems like a good option. Students First policy. At BU, students can request a P/F and it will not touch their GPA. Retroactive P/F are permitted.
 - -Marty A note could be placed in that semester as far as "Covid-19" reasoning for P/F. Other schools will accept a P/F for transfers. There are behind the scenes for P/F.
 - -Carla Constituents are divided. Whatever we do, educate the students as to the ramifications. In her classes, students are not reading. Remember, not all our students go to a 4-year school.
 - -Joe-Oswego limit up to 12 credits and will vary by program and degree ACCT will not be accepted as P/F for example. P/F might not bode well. Oneonta will be generous. So, it is dependent on the accepting school. Shift down a gear or two....
 - -Rachael If we give a P/F we do not have a number for P. It could put a student in a bad situation. What about the summer? What are the long-term ramifications? Think about competitive admissions. Think long-term 5 years down the line.
 - -Gina- Look at the Google Doc for more information It's a campus- based decision. With appropriate advising. Do not go all P/F.
 - -Ben- from a student point of view its hectic. Nobody really understands how it would work. Personally, he thinks about transfer credits.
 - -Richard- Students should opt-in. Zoom advisement maybe? Could a student request (in a year's time) to change the grade from P to C?
 - -Andrea- We do have a grade-change form.
 - -Marty Grade change forms are available for 1 year. Approved by faculty member and Dean. Is a P a C and above?
 - -Rachael in an accredited program D is failing.
 - -Penny With the number of opinions to make a small proposal for people to review. Or forget it.
 - -Andrea and Gina will send something out this week as far as a proposal. Maybe a P/F is up to the instructor and has 1 year to change it if needed for transfer. Health sciences cannot participate.
 - -Richard A P should be a C or above.
 - -Andrea Academic Advising should be included in this option.
 - -Gina Anyone have a motion?
 - Rick Motion to write a proposal for the P/F options that will be sent to CAI members by 4/9 and find a speedy way to vote on it. Racheal said we could use a Google Form to vote. Timmy seconds the motion.
