1. Review feedback & questions from member's and their constituencies

- Sarah: a lot of wording feedback. Going to send to Andrea directly. Read some of it to CAI.
 - Also stressed a need for consistent timelines in readmission.
 - Concerns about how this all affects retention.
 - Submitting letters to a committee can be intimidating for students.
 - Make sure people can apply for readmission starting in the next semester, don't keep people out for a semester.
 - Procedural concerns: who is creating the procedure? Many clarifications requested about circumstances listed.
 - Other questions as well.
- Jen:
- Is there still something like fresh start? Should it be part of it?
 - Marty response: fresh start has no bearing on academic standing.
- For competitive programs, would a spot need to be held for them for this to play out? (Up to 3 consecutive terms) If it works differently for said programs that should be reflected in the document.
- Carla:
 - Concerns similar to what Sarah has said. Cautioned about good intentions not always being what is best for students.
 - Program chairs liked having input.
 - Would like committee part taken out.
 - Do we require 3 consecutive terms as non-matriculated? They can't afford that and we'll lose the students.
 - Feels like we're treating them like the unvaccinated... is this too much, too many hoops, too severe when maybe they just had a bad semester?
- Timmy: can we do extended probation? One semester performance can enhance the probation period to give them time to avoid being dismissed.
 - Marty: if someone dismissed, they come back and are on a plan and they have a good semester while not meeting overall standards we don't re-dismiss them, we keep them on probation. Not true about before dismissal.
- Sarah: some more wording commentary.
- Gian: Is it possible, for Timmy's point, that a student has 2.0 a bunch of semesters in a row after getting dismissed, their GPA never hits 2.0 so they can't graduate. Can they pay or receive financial aid for X semesters and not be able to graduate?
 - Gina: pointed out you can't get dismissed after 1 semester in this policy. Being "on a plan" should



mean they are on some track to end up graduating. As long as they are on their plan they won't be kicked back out, just may be on probation. (A lot of this is rooted in Federal financial aid regulations, some copy/pasted). Reviewed the purposes the committee was targeting when working on this policy.

- Dr. Haynes: concerned about having one person make these decisions alone. Liability and consistency issues become more possible.
