VI. Report from VP of Academic Affairs - Dr. Penny A. Haynes

Writing emphasis question: met with departments, there was a committee, some sections have "writing emphasis" while some don't. This group should talk about it, recommends we remove the "writing emphasis" from courses since consistency is missing across the campus. Not best for students.



Removal would not affect graduations for students.

- -Gina: Changes reviewed in meeting.
- -Jen: question about how the language about "holding a spot for a year so that students don't have to reapply" applies to competitive clinical programs. If they wouldn't have to hold a spot, the document should reflect that. Concerns about holding a spot when people are trying to get in to the program. (Dr. Haynes: hard to believe we would save spots for these. If people fall short you kind of need to let others have the opportunity). Multiple people from HS agreed with this overall thought. General sentiment that in general students should have to reapply, not have a place held for them in competitive admissions programs.
- -Gina: maybe some fine print should be added that this won't apply to competitive health science programs. Discussion followed about adding language for this.
- Gina: important to note students can continue taking classes at all points in this process. This is only about being matriculated.
- -Marty: Remember a lot of questions would be addressed by the procedure, which will come next. Vote regarding endorsement Mary: shouldn't we table for one more week to speak with health sciences people?

New language suggested by Timmy that would address the competitive adminssions concern. Gina added to the document.

- VOTE TO accept WITH ADDITION: Andrew: moves to accept the document with today's revision. Gina 2nd. All in favor.

b. New Business

- i. Dates for SUNY Broome spring break for 2023 & 2024 –Marty: revisiting calendar. Spring break this semester is very late in the semester. Concern it should be earlier in the semester. 7/1/7 plans suggest that the 1 week in that format should be used for the spring break.
- Sarah: can spring breaks ever line up with breaks in the community districts? Marty: in the past yes. May be the reason our break is so late now. We would establish a calendar based on what we think BOCES will choose to do.
- Mary Seel: We are a community college, many students have children. It's a service to them to align spring break to theirs. Marty: We wish BOCES would decide sooner but we have to decide before they do. I agree if we can do that it would be preferable. Mary: moving to the middle of March would make it unlikely we align.
- Mary D: "religious observance" is a legitimate reason for our students to miss class. The week before Easter can be an issue for this if it is not break.
- Carla: teachers have to be in the classroom. We can't take the days off like students can.
- Will be getting constituent feedback for spring 2023 dates. Marty needs to get that into the system.
 - ii. New designation on "WE" courses, "PED" courses, "local Civ ed" courses.
- Dr. Haynes: The WE label is inconsistent and unclear. Varies from section to section within the same class in spots.
- Dr. Anderson: questions about the requirements in programs. How it impacts transferring. Why some classes but not others? There should be a base line of writing emphasis throughout all courses. In courses that have it, is it assessed? Who does so? Designation not appropriate to be placed on courses until this is formalized. We don't oppose, but is this a necessary requirement considering pathways?
- Ellen B: there are specific procedures a course must go through to be labelled as WE. Employers stress how important it is for students to be able to write. Many programs to fit in the 60 credit cap cut ENG111, so most students are getting at most 1 semester of writing. This is not enough. Writing is different in different disciplines. Writing needs to be taught across all disciplines. The inconsistency recently is due to people being overextended.
- Mary Seel: discussion has happened about resuscitating WINC committee so this can be overseen properly. Moving ENG to 7/1/7 format would be even less time spent working on writing for students.
- Carla: students are missing a lot that should be covered by all 3 of these course labels. Doing students a disservice if we don't teach them these things.
- Andrew: Labels useful to other programs so they know what courses cover requirements. Can see Jeff's point and perspective. Communication skills valued in many work places. Would propose that there might be some way to put the technical issues, like the designators, on hold and getting after this from an academic perspective. Revitalize a cross campus writing movement while this is on pause.
- Jen: Was on WINC committee a long time ago. Was worthwhile work. Faculty worked with faculty, great collaboration. Also mentioned there is a lab that some sections have WE but others don't so that students can take the version of the lab that meets their needs.
- Dr. Haynes: Not trying to challenge everyone, but at times when people are asked why classes have the designation they are unable to clearly explain why a course does or does not have it. Clarity and consistency have to be addressed. This stuff all needs to mesh with the ILOs. Communication is



important. There's work to be done to clear it all up.
