 - Second
 - Vote passes 13 to 1 in favor of supporting the recommendation
 - Carine will communicate this to Dave Ligeikis
- b. Proposed Change to the Student Academic Appeals Procedure (Review of Feedback)
 - Feedback from constituency
 - Reciprocity for civil behavior for both student, faculty & staff
 - Overall Academic appeals process should be reviewed
 - This shouldn't be in the appeals process as it is already covered in the Student Conduct agreement
 - Ciara Cable motions to vote to support the added language in the Appeals Process
 - Second
 - Vote does not pass 2 for and 11 against
 - Now open for discussion in COI for an alternative recommendation
 - Motion: Recommendation from COI to support the formation of a College Assembly workgroup that consists of both students and faculty that will review and make recommendations to the Academic Appeals Process. This workgroup should include no less than 2 students or 30% of the workgroup membership, (whichever is greater) and faculty recommendation from each of the 4 academic divisions to include a chair, a dean and a support staff member and representation from the division of student development.
 - Voted to move to this alternate recommendation
- c. Gender Neutral Restrooms SA Resolution (Review of Feedback)
 - Bathrooms of each building be converted to a gender neutral bathroom
 - Issue of forcing handicapped person to utilize a gender neutral bathroom regardless of their preference
 - Cathy Williams creation of a single "family" restroom that provides a safe places for people to use the restroom
 - How to provide privacy and safety for the entire population
 - ADA Standards all restrooms should be handicapped accessible
 - This will be a part of the Your Voice Matters
 - Orion Barber would like to table this matter until the "Your Voice Matters" and conduction of an electronic survey to the entire campus
 - Tables in Inactive Old Business until the YVM and Survey have been conducted.
 - Orion Barber requests that the feedback be sent out to the members
