V. Chairperson Report/Updates

A. Shared Governance Chairpersons -

- Assessment to shared governance: Request to assess the effectiveness of the committee, reporting on the structure and how it is different from other campus/institutions
 - Giovanni Scaringi: Looking at how all of the shared governance groups are working, and what our future role in shared governance will look like.
- Chancellor's award
 - Need to form a committee for the nominated individual
 - January packet submission will be due
 - Student Volunteer needed
 - Need two non-teaching service staff members to volunteer

B. College Assembly Update -

• Glovanni Scaringi gave updates related to chemistry lab fume hoods

- John Ruck & Phil Testa: Received a complaint from an instructor about building being unsafe. Involving the exhaust hoods in the labs (NSB)
 - Phil Testa remarked that "At no time was the NSB left uncovered by sprinklers and this was not deemed a life safety issue"
 Therefore the building was deemed safe for people to occupy.
 - Phil Testa There are safety measures that kick in if mechanism fails sending an audible signal to each hood and it will activate audible alarm (the instructor shut off the alarm and did not notify maintenance about the alarm)
 - Simplex system rep. Will come Wednesday to reprogram the system to make sure it remains operational.
 - Currently there is no way for maintenance to know without instructor telling them that the alarm is going off.
 - Instructors are supposed to evacuate the classroom however, this specific instructor did not
 - Instructor's responsibility for life safety training policy
 - The alarm was manually silenced, not by maintenance or PS.
- **Action**: 1.) Public Safety & Facilities are having the safety representative coming to test and make sure the system is to code.
- **Action** 2.) Life Safety Presentation: Adding if hood goes down staff should evacuate everyone in the room
- This was brought to CAI if it makes it to CoI we will make a formal recommendation when/if it does get to this level.

- Restroom update in Women's Room of Titchener
 - Security notified maintenance about a flood in that building plumber had place do not use tape in the stall and went to get supplies. This issue was resolved later that same day
- SHPO Carnegie Library: Historical Tax Credits process/guidelines for what you can/can't do to a historical building to maintain the funding.
 - Mezzanine levels SHPO recommended that they renovate the space but not use it or it would jeopardize the tax credit from parks & recreation (they dispense the money)
 - Phil Testa Disagrees with this recommendation
 - Phil and his team have offered several alternative options to SHPO trying to keep in line with the regulations for historical renovations
 - Hired a seasoned consultant to assist in options to move forward- The representative is making arrangements for SHPO/consultant to visit the site to discuss options for SUNY Broome moving forward on the project.
