X. Reports from Committees/Working Groups/Chairperson Report/Updates Textbook Committee

Cheryl Smith from the FSA (Faculty Student Association) and several others are guests here today to speak to the textbook issues

Bookstore worker gave wrong textbooks and the bookstore would not refund because the refund time had passed, these students had to purchase another textbook

Issues with customer service at the bookstore

Bookstore is not ordering enough textbooks upfront to meet the needs

This issue is across the board over several courses, not just one or two courses

The phone was not answered at the bookstore and emails were not returned until the following week, orders were lost, it was busy, lines were out the door

We have been let down by Follett, they need to tighten up and follow through Textbook request to bookstore was last April and some instructors have not put in a request

Another issue, students say there are no books but instructors went to books tore and took pictures of books, in some cases students were not telling the truth

Student said they have no money for books, but this student purchased a pair of headphones for \$100

High number of instructors requesting custom books, from a textbook committee standpoint this may not be the best option, no return value, etc.

Overarching problem, system requires contact with six people just to order a textbook which creates situation for more mistakes

No consistent person in some departments to handle textbook ordering

New system, go from Follett to instructor back to Follett

Between fall of 2016 and fall of 2017 there were many fewer issues

Suggestions from Textbook Committee were implemented by bookstore which helped

Direct line of communication specific between faculty and bookstore, email and phone line An online ordering system would be much better

Recommend an Ad Hoc committee to hash out a process that addresses book ordering, inventory, etc.

Textbook Committee could do this with additional members, some working group

Main charge of textbook committee from Dr. Battisti is to explore OER, they would prefer that a work group be formed to handle these textbook issues

Much discussion about textbook issues and working group was created, charged to come up with better procedure for ordering textbooks, how many, how to order, etc. to work with Follett and CAI to develop working solutions/policies

Adoption request forms coming next week with option to sign up and put order in online Dr. Ross will convene the working committee on textbook ordering procedures. The committee includes: David Brown, Lisa Hughes, Rachael Hagerman, Kristin Dempsey, Stephanie Malmberg, Dawn Kutz, and Mary Seel.
