B. SUNY Broome EIT Accessibility Plan

- Kim McLain
 - a) EIT plan sent to SG bodies for their review
 - b) Background - Last June SUNY passed a SUNY EIT Policy mandate that every SUNY Institution select an EIT Accessibility officer. SUNY Broome has elected an officer and developed an advisory committee who helped formulate the EIT plan.
 - (1) SUNY gave high KUDOS to EIT Committee and is using SUNY Broome as an exemplar for the rest of the SUNY System
 - c) Developing plan for 5 standards
 - (1) SUNY Provided tables highly and recommended items to include
 - (2) Currently Enacted
 - (a) Library Accessibility Web Page for students with disabilities
 - (b) Ally website checker
 - (c) Site improve scanning the website that compare us against other sites for accessibility we are currently at

- (3) Developing Procurement processes that will impact purchasing items. Any EIT purchase needs to have an accessibility check to ensure big ticket items are accessible before the college purchases it
